Material gathered by Joseph M. Albright, concerning his time as an inmate of the Albany Orphan Asylum, 1928-1943, with related materials.

Scope and Contents of the Records/Papers/Collection

Joseph M. Albright (1926-2024) became an inmate of the Albany Orphan Asylum at the age of two, following the death of his mother. He remained in the Asylum (renamed the Albany Home for Children in 1935) until he enlisted in the Navy in 1943.

The material in this collection consists in part of a typewritten history of the institution from its founding in 1829 until its reorganization as the Parsons Child & Family Center in the 1970s. More interesting is the material gathered by Mr. Albright and largely arranged by his son Tim, including photographs and photocopies of photographs of his contemporaries in the Asylum, and newspaper articles (mostly photocopied) dealing with his time there. Included also are materials prepared for, and newspaper articles on, the first reunion of Asylum alumni in 1989, with a list of alumni attending the gathering.

Organization of the Records/Papers/Collection

Materials are arranged topically by folder, with photographs of Asylum inmates in a small box.
