Biography/History of

Jeanne Finley is a writer-turned-photographer. Born in the central Adirondacks, she grew up in western New York, returned to the Adirondacks, then lived in Boston, and has lived and worked in the Capital District since 1971. She has taught creative writing in all genres, worked as the first assistant to the directors at the New York State Writers Institute from its inception in 1983 until 1991, and was assistant editor at *New York Archives Magazine*, published by the New York State Archives, for 13 years. She has exhibited her photographs since 2015 at various venues and galleries in and around the Capital District, including the 2017 *Artists of the Mohawk-Hudson Region* at the Albany Institute of History and Art. Six of her photos are in the collection of the Underground Railroad History Project of the Capital Region.

Scope and Contents of the Records/Papers/Collection

The following is a description of the collection written by Jeanne Finley, Photographer, November 2022:

"From August 2007 to August 2020, a period of thirteen years, I attended and photographed thirty-nine rallies, marches, protests, demonstrations, and vigils held in Albany that addressed and supported a variety of progressive social justice and political issues. This number by no means represents all the rallies or marches that took place in Albany or the Capital Region over those years, only the ones that I had some stake or interest in attending or that I was able to cover. I began by photographing the annual marches, sponsored by the Muslim Solidarity Committee (of which I was an original member), in support of the defendants in the Aref-Hossain sting case (see "Descriptions of Events," August 15, 2007). And thus my interest grew, over time, in photographing other marches and rallies centered on often-related social justice causes.

I had to stop attending marches in late 2020 due to a mobility problem; eventually I couldn't march any distance or move fast enough to keep up with the action. Because of this, I wasn't able to photograph the numerous local Black Lives Matter marches and rallies that captivated Albany and the rest of the country just before and during the Covid pandemic in 2020 and 2021. But you will find here photos of earlier and smaller rallies centered around Black Lives Matter and the movement's issues, in 2014 and 2016.

This collection consists of 224 photographs, in both color and black and white, a selection from the thousands I took at all these events. To document them, I give each event's location; a brief explanation of its purpose; its sponsors, as much as I could remember or research them; and background information about the event. Identifying participants in the photographs was daunting, but I've done my best (with a little help from my friends).

I think of these photos as photojournalism, though I didn't train as such (my background is in writing and editing, though now photography is my main creative practice)—a way to belatedly fill in the "photo-" end of things that the journalist in me always wanted to express. I am also happy to contribute to the documentation of the many outlets for political action that continue to exist in Albany, New York's capital. Like all capital cities,

Albany is a political town; I hope these photographs give insight into not only the issues of the time but also the variety, beliefs, dedication, passion, and history of so many of Albany's political groups and citizen-activists."

Series 1: Aref-Hossain Rally & March, August 15, 2007

Sponsor: Muslim Solidarity Committee

Location: Rally beginning at Washington Avenue Armory, corner of Washington Ave. and

Lark St., then a march up Central Avenue to the Masjid As-Salam at 276 Central.

Purpose: First annual public event after the men's convictions; solidarity and demand for

their freedom.

Background: I was part of the original citizens committee, formed in 2006 and later called the Muslim Solidarity Committee, to support two Albany Muslims, Yassin Aref and Mohammed Hossain, who were unjustly convicted in 2006 of terrorism in a much-publicized FBI sting. One of the resolutions of the committee was to keep the case, and the men and their families, constantly in the public's consciousness, so we planned to sponsor an event of some kind every year on the anniversary of their arrest, August 4, until they were freed. The event turned out to be an annual march, usually down or up Central Avenue and centered at the Masjid As-Salam at 276 Central, where the two men were members (Yassin Aref was the imam at the time of his arrest; Mohammed Hossain was the mosque's cofounder). I began photographing these marches (which I helped organize) from the outset in 2007, with only a few years missing, through the return of Mohammed Hossain to his family in Albany in 2020 after serving his sentence. Yassin Aref was freed in 2019 and was deported—happily—to his native Kurdistan in northern Iraq to join his extended family.

Series 2: Aref-Hossain Rally & March, August 22, 2008

Sponsor: Muslim Solidarity Committee

Location: Rally beginning at the Washington Avenue Armory, corner of Washington Ave. and

Lark St., then a march up Central Avenue to the Masjid As-Salam at 276 Central.

Purpose: Solidarity with Aref and Hossain and their families.

Background: Annual march in solidarity with Aref and Hossain and their families, to

commemorate the anniversary of their arrests on August 4, 2004.

Series 3: Aref-Hossain Rally & March, with Fort Dix 5 Families, August 4, 2009

Sponsor: Muslim Solidarity Committee

Location: Rally beginning at the Washington Avenue Armory, corner of Washington Ave. and Lark St., then a march up Central Avenue to the Masjid As-Salam at 276 Central.

Purpose: Solidarity with Aref and Hossain and their families; solidarity with and support for the families of the Fort Dix 5 defendants.

Background: The families of defendants in an unjust 2007 New Jersey terrorism case dubbed the "Fort Dix 5" (involving three brothers, a relative, and a friend) reached out to Muslim Solidarity Committee members for support. The committee invited them to come to Albany and march with them for the annual Aref-Hossain march.

Series 4: Occupy Albany, October 15, 2011

Sponsor: Informally: NYSUT (New York State United Teachers), Muslim Solidarity

Committee, Veterans for Peace, many individuals

Location: East side of State Capitol.

Purpose: To rally citizens who supported Occupy Wall Street in New York City and its demands for economic justice and equity for working people.

Background: Although Albany's Occupy protest (and later encampment) didn't officially begin until a week later, this rally brought together workers from public sector unions and interested citizen/activists as a prelude to see what kind of support an Occupy movement in Albany might have.

Series 5: Occupy Albany, October 21, 2011

Sponsor: Various progressive social justice groups, political parties and organizations, unions (including Solidarity Committee of the Capital District), and private citizens.

Location: A march down Washington Avenue past the Capitol to Academy Park on lower Washington Ave.

Purpose: To formally begin Occupy Albany by establishing an encampment in Academy Park.

Background: Occupy Albany lasted from October 21 to December 22, 2011.

Series 6: Occupy Albany, October 29, 2011

Sponsor: Occupy Albany, which quickly built its own website and listservs and became its own sponsor.

Location: Academy Park, lower Washington Ave.

Purpose: To occupy the park as a "tent city" (dubbed "Cuomoville") until various demands for economic justice and equity for working people were met.

Background: Participants often spontaneously organized marches on lower Washington Ave., including to the governor's mansion on Eagle Street, or stood streetside with signs. Each day had a different schedule of actions. Speakers on this day included Congressman Paul Tonko, State Assemblyman Jack McEneny, Dutchess County legislator and congressional candidate Joel Tyner, Albany Common Council members Barbara Smith and Dominick Calsolaro, and several citizens. The day's activity was called Occupy Your Capital Day.

Series 7: Occupy Albany, Night, November 19, 2011

Sponsor: Occupy Albany

Location: Academy Park and Lafayette Park, lower Washington Ave.

Purpose: Refusal of Occupy participants to leave Academy Park; temporary occupation of

Lafayette Park.

Background: Governor Andrew Cuomo objected to the presence of Occupy participants in Academy Park, controlled partly by the City of Albany and by New York State and home to the offices of the Albany School District. Occupy protestors had descended on the governor's mansion in a previous week when Cuomo refused to reauthorize an income tax surcharge on New Yorkers making more than \$200,000 a year, thus earning him the title "Governor One Percent." In response, Cuomo pressured Mayor Jerry Jennings to have Albany police arrest Occupy protestors for staying in Academy Park after an unposted 11 p.m. curfew. But District Attorney David Soares said he would decline to prosecute the protestors, so Cuomo ordered the State Police to start making arrests. Participants then organized a night rally in Lafayette Park, just up Washington Ave., controlled by New York State and named in honor of the Marquis de Lafayette (who had commanded troops at Albany in 1778). They expected the arrests (48 total over the course of a week), which they considered acts of civil disobedience that upheld their First Amendment rights to peacefully assemble and demonstrate, but ultimately did not withdraw the encampment from Academy Park. Trespassing and disorderly conduct charges were later dropped.

Series 8: Rally/Vigil Against NDAA & Indefinite Detention, December 15, 2011

Sponsor: Muslim Solidarity Committee, Occupy Albany, Tea Party, Capital Region chapter of New York Civil Liberties Union

Location: In front of Albany City Hall on Eagle Street, across from Academy Park.

Purpose: To protest passage of the National Defense Authorization Act (NDAA) for 2012, which for the first time formally authorized the indefinite military detention of people the federal government suspected of involvement in terrorism, including U.S. citizens arrested on American soil.

Background: Called the "Obama NDAA," these detention powers still face legal challenges.

Series 9: Occupy's End, December 22, 2011

Sponsor: Occupy Albany

Location: A rally in Academy Park; a spontaneous march down State Street to North Pearl

Street, then up Lark Street to Washington Avenue and back to Academy Park.

Purpose: Refusal to leave Academy Park despite warnings that the police would physically evict protestors and demolish the Occupy encampment.

Background: Word had come down from Mayor Jerry Jennings that he would direct the Albany Police Department to finally clear the park—although, significantly, not on this date—citing as one of the reasons the presence of homeless people and associated crime. City attorneys claimed that their only concern was the safety of the participants. Jennings was supported in this by Governor Cuomo. Occupy participants said publicly that they would refuse to leave. In late afternoon the Department of General Services suddenly began hauling away protestors' tents, signs, and other items in garbage trucks. Occupy protestors and interested citizens rallied in the park at sunset and, bearing aloft the huge orange tent that served as the main information center for the encampment, began a large spontaneous march down State Street, through downtown on North Pearl Street, then up Lark Street and down Washington Avenue back to Academy Park. The police provided security on horseback and let the protestors complete the march, which took over an hour, without interference. However, once back in the park, the police seized the tent and began to move participants out of the park, and Officer Richard Gorleski on horseback began pepperspraying them for no apparent reason. Many protestors were pepper-sprayed, including

some prominent citizens who had joined the march (including Willie White, director of the South End advocacy organization, A Village), and this escalation led to anger and confusion. The police proceeded to tear down the large orange tent and evict most of the protestors, who left in keeping with Occupy's rule of non-violence. The encampment was demolished, but a few protestors remained to sing and place signs.

A note: 2011 was unusually warm for December, which probably allowed greater participation in the encampment and associated actions. The warm weather continued into January.

Series 10: Occupy Solidarity, January 5, 2012

Sponsor: Occupy Albany, MoveOn.org

Location: Lower Washington Avenue and Academy Park.

Purpose: A rally in solidarity with the spirit of Occupy Albany.

Background: Though the encampment was gone, protestors rallied with signs on Washington Avenue to show the public, the city administration, and the governor that the many issues that Occupy Albany highlighted concerning economic justice and restoring democracy had not been either forgotten or dealt with. A march then progressed uptown to Lark Street and returned to Academy Park for a candlelight vigil.

Series 11: Occupy May Day, May 1, 2012

Sponsor: Occupy Albany

Location: Academy Park, then marches uptown and downtown.

Purpose: To continue the actions of Occupy Albany on the economic issues it highlighted,

on the traditional May Day/workers' day.

Background: A rally began in Academy Park, then protestors broke into different marches, which covered State Street, Pearl Street, and Broadway, stopping at Bank of America, Verizon, the State Education Department building, and the Greyhound bus station.

Later that evening, according to 1199/SEIU (Service Employees International Union): "At 10 p.m., Occupy Albany returned to the spot in [Academy] Park where they first pitched their tents last October. Aware of the 11 p.m. curfew, about 80 people gathered, a drum circle

banged out a backbeat, and state troopers approached. The crowd chanted, 'We are unstoppable; another world is possible.' Then, one by one, twenty protesters were arrested by State Police after 11 p.m."

Series 12: Aref-Hossain Rally & March, August 4, 2012

Sponsor: Muslim Solidarity Committee

Location: Rally at the Masjid As-Salam, 276 Central Avenue, then a march up Central

Avenue and return to the mosque.

Purpose: Solidarity with Aref and Hossain and their families; to remember and support other unjustly prosecuted Muslims and their families in the "War on Terror."

Background: The Muslim Solidarity Committee invited family members of several unjustly prosecuted Muslims from around the country to march with them in the annual Aref-Hossain march. A candlelight vigil was held outside the Masjid As-Salam, and then several family members spoke inside. Participants were urged to write to prisoners so they would not be forgotten.

Series 13: 1st Anniversary Occupy Albany, October 21, 2012

Sponsor: Occupy Albany Location: Academy Park

Purpose: Commemorate the first anniversary of Occupy Albany with spontaneous speeches about the issues it raised; solidarity for protestors who had charges pending. Background: Four members of Occupy had been arrested by police in June for obstructing traffic during a planned march downtown and were charged with disorderly conduct; this was seen as harassment. One member was also charged with misdemeanor resisting arrest. District Attorney David Soares declined to prosecute (he had been unwilling to prosecute Occupy protestors during the encampment, withstanding pressure from the

mayor, governor, and police), but a city judge threatened to hold the DA's office in contempt if it did not prosecute, despite an earlier decision by another city judge that similar charges against Occupy protestors should be dismissed (and were), precisely because the DA did not prosecute. In this case, the charges were finally dismissed, but only after the dispute between the DA and the judge went to the Court of Appeals and the judge lost.

Series 14: Free Gaza, July 31, 2014

Sponsor: Palestinian Rights Committee, Jewish Voice for Peace

Location: Dana Park, Delaware, Lark and Dana Aves.

Purpose: Protest Israel's deliberate bombing of the Gaza Strip in the 2014 Gaza War. Background: Another similar protest was held in the same location a week later.

Series 15: August 4, 2014, Aref-Hossain Rally & March, 10th Anniversary of arrests, with play performance, *To Catch a Muslim*

Sponsor: Muslim Solidarity Committee

Location: Rally beginning at Washington Avenue Armory, corner of Washington Ave. and Lark St., then a march up Central Avenue to the Masjid As-Salam at 276 Central.

Purpose: Commemorate the 10th anniversary of the arrests of Aref and Hossain on August 4, 2004; present an original play about the case.

Background: After the march, in the mosque the Muslim Solidarity Players performed a play written by attorney Steve Downs, *To Catch a Muslim*, about the Aref-Hossain case from arrest to unsuccessful appeals, featuring the main "characters" including Aref, Hossain, the informant, the trial and appeal judges, and the FBI agents. Some dark humor and a lot of irony were voiced. The play was subsequently performed twice at other venues in the Capital District.

Series 16: Rally/Vigil for Michael Brown/Black Lives Matter, November 25, 2014

Sponsor: Capital Area Against Mass Incarceration (CAAMI), Black Lives Matter, Bethlehem Neighbors for Peace, First Unitarian Universalist Society of Albany, Albany Social Justice Center, Holding Our Own, Inc. and Citizen Action of New York Location: In front of Albany City Hall, Eagle Street; march to Federal Building.

Purpose: A rally, vigil, and march to protest the murder of Michael Brown by police in Ferguson, Missouri.

Background: On August 9, 2014, 18-year-old Michael Brown, an African American teenager, was shot and killed by a white police officer after an altercation at the police car and subsequent short chase. Witnesses to the shooting claimed Brown had his hands up in surrender or said "Don't shoot," so protesters later used the slogan "Hands up, don't shoot." Protests across the country against police brutality toward African Americans continued for more than a week. On November 24, a grand jury concluded that the police officer would not be indicted. The shooting galvanized the Black Lives Matter movement nationally and sparked this protest.

Series 17: Jewish Voice for Peace/Chanukah/Black Lives Matter, December 16, 2014

Sponsor: Jewish Voice for Peace, Black Lives Matter

Location: Dana Park at Delaware, Lark and Dana Aves.

Purpose: To show support for the Black Lives Matter movement within the Jewish community, on the occasion of Chanukah.

Background: In July, Eric Garner, an African American father of six, was killed on Staten Island when he was put in a chokehold by a white police officer. Protestors subsequently used the slogan "I can't breathe" (apparently Garner's last words). Chanukah/Hanukkah is a traditional Jewish celebration often falling close to the Christian Christmas; Jewish Voice for Peace, an international activist organization that supports Palestinian and minority rights, wanted to use the holiday to show solidarity with the Black Lives Matter movement (and once word got out, vice-versa).

Sponsor: Capital District Coalition Against Islamophobia and other immigrant, Black, human rights, Muslim, religious, political, and peace advocacy groups Location: Rally at Townsend Park between Central and Washington Aves. for speeches, then march up Central Ave. to the Masjid As-Salam at 276 Central for speeches. Purpose: Oppose the "100 Days" agenda of newly elected President Donald Trump. Background: In early November, Trump announced his "100 Days" agenda, tasks to be accomplished in his first 100 days in office. These included cleaning up Washington with term limits on Congress; protecting American workers; restoring the rule of law; repealing Obamacare; funding the construction of a wall at the Southern border (with a provision that Mexico would reimburse the U.S.); encouraging infrastructure investment; rebuilding military bases; and promoting school choice. The possibility of a "Muslim registry" was also floated. The focus of the rally was on immigration and opposing Trump's past misogynistic and racist remarks against women, Muslims, and other minorities. Two other rallies also took place in Albany earlier on November 19; participants were then invited to march with this rally.

This motion was successful and was helped by a petition demanding his early release because of the COVID pandemic, signed by over 500 supporters. On June 8 he was officially released, one month before completing his 15-year sentence. The committee issued a blanket invitation to anyone who wanted to come and celebrate his release; over 50 supporters were present. Mohammed spoke briefly from the steps of his home, and the Muslim Solidarity Committee ended its mission of freeing the two men (though it continues as an informal group to date).

The protest, titled "Stop the Pyramid Scheme," was intended to make planning board members aware of community opposition to the proposed expansion and support for the Pine Bush ecosystem.
