Biographical/Historical

Matthew Bender IV was a founder in 1974, first President (1974-1982), and long-time Board member of the Historic Albany Foundation (HAF). The Foundation is a not-for-profit organization that works to preserve and protect Albany buildings of architectural, historic, or civic value. The materials Mr. Bender collected during his association with HAF (including directors' minutes, background papers, correspondence, and reports) document the internal operations, finances, policies, and projects of the organization, covering the period 1974-2013. (The collection for the earlier part of the period is more complete than that for the later years of Mr. Bender's association with HAF.) Included are correspondence and other items by and relating to Lorraine Merritt, HAF's first executive director (1974-1981).

Scope and Contents

Contains materials relating to HAF and its projects and operations, collected by Mr. Bender as president and board member of the organization. Letters, reports, financial statements and related materials dealing with the operation and projects of the Historical Albany Foundation.
