Abstract: This is a collection of photographic images made for the stereoscope, a 19th century means of viewing photographic images like the 20th century slide projector or the 21st century power point. Most of the images in the collection deal with the city of Albany and represent about ten major photographic studios or studio collections from that era. The balance range throughout New York State, from Central Park in New York City, to Niagara Falls on the western border with a limited international section.

Biography/History of

This collection of stereo cards appears to have been amassed over a period of time. It represents a diverse collection of images giving insight into the entertainment and interests of the residents of the Albany area from the last half of the 19th century through the first quarter of the 20th. Most of the collections of images were done by studios in the Albany area, the most substantial of these collections is the Wendt collection, Julius M. Wendt photographer; the Hurst Collection which is primarily a natural history collection but has within it a collection of comedic images utilizing animals to represent the human situation. There appears to be 7 different sets of the Hurst Natural History Collection represented, most only a few images, the largest of the sets is numbered 1-60 with numbers 11,12,14,15,16,18,19,21-25,27,28,30-33,37,39,40,41,43,46,48,49,50,51, 53, 54, 58 & 59 missing. The Hurst Collection was purchased from Holzman in 1984. Another Albany studio well represented is the Veeder Collection, unlike Wendt; the Veeder Studio appears to have photographed all over New York State since their images appear throughout the collection with the various locations represented in the stereo card collection. Other studios represented are W. Notman, McDonnald & Sterry, Crane, JH New, Union View, Holmes and American Scenery. Pike is the only studio with no apparent Albany connection in this collection.

The diversity in the collection shows an expanding interest in the world and the ability of photography to bring that world to the parlors of Albany, NY. Images of children making shawls in Kashmir, the Great Sphinx of Egypt, funeral arrangements

(floral) for a family funeral and the US Grant funeral are among the more exotic images in the collection. There is a solid representation of the cities of Albany, Saratoga Springs, and Cohoes NY which gives a good visual image of turn of the century in the Capital District. Images of Washington Park, the Albany Rural Cemetery, the hotels of Saratoga Springs, Niagara Falls and the natural images of places like Watkins Glen and Ausable Chasm give a taste of the beautiful and the sublime so important in 19th century art and architecture.

Scope and Contents of the Records/Papers/Collection

This collection contains a continuum of images of architecture, people and events in and around the Albany area from the Civil War (1860's) through the World War I era. A secondary theme is a natural history collection representing a broad spectrum of animal and bird populations throughout North America. A third unit, and much smaller group of cards in this collection, represents random images from NYC, views through the Hudson Valley, west though sections of Central NY to Niagara Falls, unidentified images and a small international grouping.

Organization of the Records/Papers/Collection

There are three boxes of cards, organized by categories that reflect either photographer or subject matter; within the category divisions, where possible the images are grouped by photographer, all are chronological within that subset.

The finding aid is set up to describe the image and then the verso of said image. Any printing on the cards is noted starting on the left, since the identifiers began on the left in the first two boxes. The location of the identifiers changed in the third, but for consistency the printing on the ends of the cards continues from left to right.

If ink or a particular color of pencil is not noted, the writing is most probably in pencil. It is assumed numbers noted on the verso are earlier versions of accession numbers for the collection and are included in the verso information.
